Using the most modern tests and software, the Program Specialist creates literate, highly individualized reports about the strengths, weaknesses and needs of each child evaluated, including specific recommendations for educational, behavioral and social-emotional interventions as necessary. These reports are delivered in draft form for review and approval to a Certified School Psychologist and licensed professional psychologist who observes the child in the classroom as necessary, counter-signs each report and is available as necessary to assist the school in presenting the contents of the evaluation report to parents and others. Consultations with school faculty, administration, and parents/guardians regarding special education regulations and other matters related to the delivery of special education services in a Charter School are also available.

The Program Specialist possesses *extremely* well-developed social and written communication skills and continually develops these skills through a mentoring relationship with a Licensed Professional Psychologist and Certified School Psychologist supervisor. The Program Specialist has had graduate-level training and practical experience in the use of the latest versions of the **WISC** and **WIAT** in addition to training in various behavioral measurements and intervention techniques, specifically tailored for success in a school setting.

The Program Specialist can provide teacher consultations regarding student disruptive behavior problems and learning problems, student and parent consultations regarding behavioral or learning concerns, organizational consultations with school administration concerning policies and procedures, consultations regarding Special Education regulations and implementation strategies, and participates in Child Find activities as requested.

The Program Specialist conducts a *Functional Behavior Assessment* (FBA) as requested to investigate the reason(s) underlying a child's display of unacceptable behavior and can use data collected from this procedure to design appropriate Behavior Support Plan(s) for the child in school. Active participation by the child and his/her parent/guardian(s), and the child's school faculty and administration is encouraged by the Program Specialist, who solicits input from these parties in the creation of all diagnostic reports or behavior support plans.
